### Background

Financial Advisers are authorised and Regulated by the Financial Conduct Authority (FCA), unlike Pension on Divorce Experts (PODEs). You can theoretically locate one via the FCA register, but you need to know the firm or individual name. The main alternative is <u>https://www.unbiased.co.uk/</u> which lists some 27,000 financial advisers. I have not located an option to filter the list to find those familiar with supporting individuals during a divorce or implementing Pension Sharing Orders.

I have therefore gathered together a group of advisers who have expertise in working with divorcing clients. They will be able to help you during the negotiations around the financial split in terms of evaluating which assets are of more value to each party along with the associated taxation implications. Additionally, they all have experience in the process of implementing Pension Sharing Orders.
